## DECREE CONCERNING STATE ENCOURAGEMENTS TO INVESTMENTS<sup>1</sup>

#### (Decree No: 2009/15199 and dated: 14/07/2009)

#### (published in the Official Gazette dated: 16/07/2009 and No: 27290)

#### Purpose

**ARTICLE 1-(1)** The purpose of the Decree is to orient savings to investments with high added value, increase production and employment, ensure continuity of investment propensity and the sustainable development, encourage large investments contributing to international competitiveness and employing high technologies and research and development (R&D) activities, stimulate direct foreign investments, reduce regional development disparities, support investments aimed at environmental protection and R&D activities, in line with the targets envisaged in Development Plans and Annual Programs as well as international agreements.

## Definitions

**ARTICLE (2)** Within the meaning of the implementation of this Decree, the following terms shall mean;

a) Intermediary institutions: Banks and financial leasing companies including public banks which will be a party in the implementation of interest support,

b) Large investment: The investments indicated in the annex -3 of this Decree, having an investment cost over 50 Million Turkish Liras as defined in the Article 32/A of Corporate Tax Law No:5520,

c) Accounting Unit: Accounting Unit in charge of Internal Payments in the Undersecretariat of Treasury,

ç) Undersecretariat: Undersecretariat of Treasury,

d) Incentive certificate: Investment incentive certificate

e) Investment good: Fixed expenditures, excluding buildings and land, relating to machineryequipment, auxiliary equipment and furnishing, depending on the type of investment, to be used in production of goods and services within the scope of incentive certificate.

#### **Regions and support measures**

**ARTICLE 3-(1)** Within the framework of the implementation of support measures, Level 2 Regions, as specified in the Statistical Classification of Regional Units determined by the

Council of Ministers Decree dated 28/8/2002 and No:2002/4720, have been divided into four groups as indicated in annex-1 by considering their socio-economic development status. The investments eligible to benefit from the support measures provided for regional implementation are determined by considering investment potential and competitiveness of each provincial group as designated in annex-2.

(2) Excluding the investments which are deemed not to be supported and do not meet the required conditions as set forth in Annex-4 attached herewith, all investments over minimum fixed investment amount stipulated in article 4 may benefit from customs duty and value added tax (VAT) exemption regardless of the location of the investment.

(3) In addition to the support measures mentioned in the above paragraph, the investments eligible for support measures provided for regional implementation may benefit from the following;

a) In Regions I and II;

1) Tax reduction,

2) Social security premium support,

3) Land allocation,

b) In Regions III and IV;

1) Tax reduction,

2) Social security premium support,

3) Land allocation,

4) Interest support.

(4) Large investments may benefit from;

a) Customs duty exemption,

b) VAT exemption,

c) Tax reduction,

ç) Social security premium support,

d) Land allocation.

(5) Upon the evaluation to be made within the framework of macro-economic programs, supply-demand balance, financal, technical, and sectoral terms, investment projects are required to be deemed eligible and issued an incentive certificate to benefit from the support measures within the scope of this Decree.

(6) No incentive certificate shall be issued on behalf of the financial leasing company for investments to be realized through financial leasing companies. In case of failure of the investor to fulfill his obligations, sanctions imposed to machinery and equipments that are subject to leasing are partially or entirely applied to the financial leasing companies correspondingly.

(7) The investment expenditures made before the date of application for incentive certificate shall not be included within the scope of the incentive certificate.

## Fixed investment amounts and minimum capacities

**ARTICLE 4-**(1) For an investment to be eligible to benefit from support measures, the minimum fixed investment amount should be one million Turkish Liras in regions I and II and five hundred thousand Turkish Liras in regions III and IV. However, for large investments, investments within the scope of regional implementation and those within the scope of general investment system, the minimum fixed investment and/or minimum capacity requirements set forth for each subject in the annexed lists are valid.

(2) For the investments to be realized through financial leasing companies the total amount of machinery and equipment subject to financial leasing for each financial leasing company should be at least two hundred thousand Turkish Liras.

(3) No minimum fixed investment amount is required for the production facilities benefiting only from relocation support within the scope of Article 12 of this Decree.

## **Application procedure**

**ARTICLE 5-**(1) Submission of following documents are required for application to the Undersecretariat for the issuance of incentive certificate;

- a) Circular of signature of the persons authorized to represent and bind the company to realize investment project,
- b) Turkish Commercial Registration Gazette or Turkish Tradesmen and Craftsmen Registration Gazette documenting the current status of the company,
- c) Investment application form and its annexes containing information in accordance with the format provided in the Communiqué to be published pursuant to this decree,
- c) Original copy of the receipt indicating deposit of the amount mentioned in the second paragraph of this Article to the account of the accounting unit,
- d) Original of the letter to be received from the related departments of the Social Security Institution confirming that the company has no premium debt and administrative fine due or it has been deferred, credited or re-structured pursuant to Social Insurance and General Health Insurance Law No. 5510 and the restructuring is still valid,
- e) For the investments indicated in the lists annexed to Environmental Impact Assessment (EIA) Regulation published pursuant to Environment Law No 2872, EIA Report indicating affirmation of the investment in terms of its environmental impact or the document indicating that EIA Report is not necessary.

However, for manufacturing industry investments determined by Communiqué with fixed investment amount not exceeding eight million Turkish Liras excluding foreign capital investments, large investments, investments within the scope of regional implementation, research/development and environmental investments, the investor, upon preference, may apply to the chambers of industry associated with Turkish Chambers and Stock Exchange Union where the investment is located.

(2) If the application for an incentive certificate is to be made to the Undersecretariat, a fee amounting to Four Hundred Turkish Liras, and if it is to be made to the chambers of industry, a fee amounting to Three Hundred Turkish Liras is deposited in the account of accounting unit to be retained as revenue to the budget and a Hundred Turkish Liras in the account of related chamber of industry. The refund of these amounts may not be claimed.

(3) Except for the fees for expertise made upon the completion of the investments determined by the communiqués, no fee can be charged by the relevant chambers of industry for any transaction relating to incentive certificate.

(4) The assessment results of the applications made to the chambers of industry are submitted to the Undersecretariat in accordance with the procedures and rules set forth in the communiqué to be published based on this Decree. Investments found eligible upon the final assessment by the Undersecretariat are issued incentive certificate.

(5) The Undersecretariat is authorized to request additional information and comments, permission, license and other documents received from the public authorities and institutions depending on the subject of investment if deemed necessary.

## **Customs Duty Exemption**

**ARTICLE 6-**(1) Within the scope of incentive certificate imports of investment goods, CKD components and accessories regarding investments of automobiles and light commercial vehicles provided that the acquisition remains within investment period, hulls regarding building of ships and yachts with a length of more than fifty meters are exempted from customs duty determined in Import Regime Decree in effect.

(2) On the other hand, the import of spare parts not exceeding five percent of the cost of machinery and equipment, bus, tow truck (excluding those with green motors in conformity with Euro norms), tractor-trailers (excluding refrigerated trucks), furniture, motorboats, trucks (excluding off-road dump trucks), trans-mixers, concrete plants, forklifts, and concrete pumps within the scope of incentive certificate is subject to Customs Duties at the rate specified by the current Import Regime Decree.

(3) Raw materials, intermediary goods and operational materials except for those indicated in the first paragraph of this article cannot be imported within the scope of incentive certificates issued in accordance with the provisions of this Decree. Additionally, passenger cars, construction materials, porcelain and/or ceramic kitchen and tableware cannot be included within the scope of incentive certificate.

(4)By considering regional and sectoral restrictions, following may be deemed compatible;

a) Machinery and equipment (excluding highway transport vehicles) deemed as appropriate for import in accordance with the provisions of "Communiqué on Importation of Old, Used and Renovated Goods" based on "Import Regime Decree" and

b) Machinery and equipment of which the importation is permitted pursuant to article 7 of the Import Regime Decree

can be included within the scope of an incentive certificate.

c) Import of used complete facility can be permitted upon the assessment of the Undersecretariat per project basis.

(5) Regarding textile and apparel investments used machinery and equipment within the scope of incentive certificate cannot be imported.

(6) As regards investments to be realized through financial leasing companies import procedures are executed by taking into consideration incentive certificate of the investor without issuing a separate incentive certificate on behalf of financial leasing company. The investor and the financial leasing company are severally liable for the import transactions.

(7) Import of machinery and equipment, concerning the investments for which application for incentive certificate is made but not concluded yet, is permitted by the Undersecretariat of Customs, upon approval of the Undersecretariat provided that a collateral in the total amount of customs duty and value added tax is deposited. For importation via depositing collateral, the period allowed in each application for the release of collateral is maximum six months. In case the collateral could not be released during the allowed period, application to the Undersecretariat of Customs is required for a period extension. The period for the release of the collateral starts on the date when the commodity enters into free circulation. The investor must apply to the Undersecreteriat of Customs for the release of collateral within the allowed period by submitting the incentive certificate and import machinery and equipment list attached to it. Otherwise, amount collected as collateral is retained as revenue.

## Value Added Tax Exemption

**ARTICLE 7-(1)** In accordance with the Law on Value Added Tax No: 3065 purchases of imported or domestic machinery and equipment within the scope of an incentive certificate are exempted from value added tax.

#### **Interest Support**

**ARTICLE 8-(1)** Upon request, for investments within the scope of regional implementation the following percentage points of interest rate or profit share to be paid for the loans extended by the banks with a maturity of at least one year and not exceeding 70% of the fixed investment cost recorded in the incentive certificate can be compensated from the budget resources for the first five years at maximum upon the approval of the Undersecretariat;

a) For the investments to be realized in Region III, three percentage points for the loans in Turkish Lira, one percentage point for the foreign currency and foreign exchange loans,

- b) For the investments to be realized in Region IV, five percentage points for the loans in Turkish Lira, two percentage points for the foreign currency and foreign exchange loans,
- c) Without considering regional classification, for research and development investments and environmental investments that are not directly related to commercial manufacturing activities and concerning refinement or incineration of solid, liquid or gaseous wastes of existing or to be established facilities, five percentage points for the loans in Turkish Lira, two percentage points for the loans for foreign currency and foreign exchange loans.

(2) For investments issued an incentive certificate with the measure interest support and realized through financial leasing companies, interest support is implemented under the same conditions provided that a disbursement plan including interest payments is prepared.

(3) The amount of interest support to be provided from the budgetary sources on project basis cannot exceed; three hundred thousand Turkish Liras for research and development and environmental investments, and five hundred thousand Turkish Liras for the investments to be made in the Regions III and IV.

(4) Regarding investments to be realized by foreign currency credits, interest support implementation is made by taking into account of foreign exchange selling rate of Central Bank of Turkey applicable at the date of maturity.

(5) The measure interest support cannot be ascribed for the following; used machinery and equipment and the investments to be realized by the public authorities and institutions including publicly owned economic enterprises and professional union organizations in the status of public legal entity. Additionally, loans provided by public institutions or subsidized by public funds are also not eligible for the measure interest support.

(6) For the implementation of interest support within the scope of an incentive certificate, application of no more than one intermediary institution is taken into account.

(7) In case of failure in the reimbursement of the interest, profit share or the principal in due period as specified in the disbursement plan for the first time, the case is notified by the intermediary institutions to Undersecreteriat within the shortest time and upon the notification the Undersecretariat suspends the payments of the interest support. In case of a subsequent notification by the intermediary institution to the Undersecretariat about fulfillment of repayment obligation by the investor, the interest support payments are proceeded for the remaining periods, without granting an extension period. In case of failure in reimbursement for the second time, payment of interest support is terminated.

(8) In case of transfer of the investment goods within the scope of incentive certificate to another investor, and if the incentive certificate of the investor taking over is entitled to interest support and with the approval of intermediary institution, payment of interest support is proceeded for the new investor in accordance with the new disbursement plan without being subject to any modification in the previous plan concerning the maturity, amount of interest support and all other conditions for the remaining part of loan. Otherwise, the interest support implementation for the transferred machinery and equipment is ceased.

(9) In case of cancellation of the incentive certificate for any reason, the amount of interest support is collected according to the provisions of the Law No 6183 Related to Collection Procedure of Public Receivables.

(10) The intermediary institution is liable to ensure the use of the loan subject to interest support for the expenditures within the scope of incentive certificate. In case the loan is determined to have been used for purposes other than specified, for the banks the amount determined by employing the interest rate specified for this loan by the relevant bank to the already paid interest support amount, for financial leasing companies the total interest support amount indicated in the disbursement plan respectively is required to be deposited in the account of accounting unit within five work days to be retained as revenue to the budget.

Otherwise, the said amounts are collected by the Undersecretariat;

- a) for banks through transfer from the reserve account in Central Bank of Turkey or by exercising other means of legal remedy,
- b) for financial leasing companies by applying the provisions of the Law No.6183.

(11) The Minister whom the Undersecretariat related to is authorized to increase the amount determined in this article up to one fold and to reduce at the rate of seventy five percent.

## Social security premium support

**ARTICLE 9-**(1) For large investments and those supported within the scope of regional implementation provided that the employment requirement recorded in the incentive certificate is fulfilled, social security premium employers share corresponding to minimum wage amount is compensated by Treasury within the periods and for the employment specified below:

a) for completely new investments all employment created after becoming operational and

b) for all other types of investments, each additional employee recruited after the notification of the average number of employees to the related Provincial Directorate of Social Security with the SSK Monthly Premium and Service Document in the last six months (for investments bearing seasonal characteristic, preceding years' seasonal average employment figures are taken into account) after the completion of the investments.

(2) No additional premium support is granted within the scope of this Decree for the undertakings currently benefiting from the support measures within the scope of the Law dated 29/1/2004 and No 5084. However, regarding these undertakings, for employment created through investments issued an incentive certificate in accordance with this Decree premium support is ascribed.

(3) For compensation of premium corresponding to employers' share, with regard to employees, SSK Monthly Premium and Service Document are required to be submitted within the legally prescribed period in accordance with Law No 5510 and for each employee's social security premium the amount representing the portion of the employers' share not compensated by Treasury must have been paid. In case of late payment of the premiums to be paid by the employer, the overdue fine arising out of late payment to the Social Security Institution by the Treasury is collected from the employer.

(4) The procedures and principles for the transfers to be made to Social Security Institution are determined by the Undersecretariat.

#### **Tax Reduction**

**ARTICLE 10-**(1) The rate of reduction applicable to the corporate tax or income tax pursuant to article 32/A of Corporate Tax Law No 5520, as well as the rate of contribution to investment for large investments and investments within the scope of regional implementation are provided herein below.

(2) However, providing that the investment within the scope of incentive certificate is to be commenced until 31/12/2010 the following reduction and contribution rates are applicable.

(3) The reduced tax implementation is ceased when the amount of reduced corporate tax or income tax reaches to the amount of contribution to investment.

(4) Expenditures concerning land, royalty, spare parts and non amortizable assets are not subject to tax reduction.

(5) The corporate tax or income tax reduction does not apply to the corporations and joint ventures operating in the fields of finance and insurance pursuant to the Law No 5520 and the investments realized within the frame of the Law No 4283 on Construction and Operation of

Electrical Energy Generation Facilities under the Build-Operate Model and the Law No 3396 for Realization of Certain Investments and Services within the Frame of Built-Operate-Transfer Model.

(6) The reduction rates does not apply in taxation through withholding.

## Land Allocation

**ARTICLE 11-(**1) Pursuant to additional article 3 of the Law dated 29/6/2001 and No 4706 and in accordance with the procedures and principles set forth by the Ministry of Finance, land can be allocated to large investments and investments within the scope of regional implementation with incentive certificate issued by the Undersecretariat.

(2) The provisions of fifth paragraph of Article 10 of this Decree are also applicable for land allocation.

# Relocation support for the enterprises operating in the textile, apparel, leather and leather products sector

**ARTICLE 12-(**1) Provided that undertakings operating in the production of textile, apparel, leather and leather products sectors in Regions I and II move their facilities completely to the provinces in Region IV until 31/12/2010 and create employment of at least fifty persons;

- a) Corporate tax or income tax reduction is subject to reduction at the rate of seventyfive percent for a period of five years in accordance with the provisional Article 4 of the Law No 5520,
- b) Land can be allocated in accordance with the principles set forth in this Decree,
- c) The employer's share of social security premium corresponding to minimum wage for the employees is compensated from the budget for a period of five years following the relocation,

(2) The moving expenses can be compensated from the budget resources for facilities completing their relocation until the end of 2009.

(3) The provisions of sixth paragraph of Article 10 of this Decree are also applicable for relocation support.

## Procedures to be executed by Chambers

**ARTICLE 13-**(1) Applications deemed appropriate based on the assessment made by the chambers of industry are submitted to the Undersecretariat to be issued an incentive certificate. Upon approval of the applications by the Undersecretariat, they are issued incentive certificates and returned to the relevant chambers of industry.

(2) All the procedures, excluding those mentioned in the subparagraph (c) of fourth paragraph of Article 6 and Article 15 of this Decree, are concluded by the related chamber of industry receiving the incentive certificate application. The investment realization figures of incentive certificates, whose completion visa are done, are notified to the Undersecretariat

according to the format to be determined by the relevant communiqué. The procedures related to completion visa are not deemed to be finalized unless approved by the Undersecretariat.

(3) The chambers of industry are obliged to employ adequate number of technical personnel on a full-time basis to carry out the procedures related to incentive certificates.

(4) The chambers of industry, which are determined to be in breach of the provisions of this Decree or to have charged a fee for the procedures other than the expertise process conducted to obtain completion visa, are withdrawn from their duties.

## Payments from the budget

**ARTICLE 14-**(1) Payments specified below can be made according to the procedures and principles stipulated in the relevant legislation and within the appropriation limit specified in the annual budget for support of investments:

- a) Payments to be made in accordance with this Decree.
- b) Balance due regarding investment and operational credits payable in accordance with the Council of Ministers' Decrees published previously.
- c) Amounts payable regarding support measures foreseen in accordance with the provisions of previous Decrees concerning State Encouragements to Investments.

ç) Return of the amounts which are inadvertently over-paid to Central Bank of Turkey for the application of incentive certificate and loss of the documents.

d) The amounts which are required to be reimbursed at the end of the court trials concluded against the Undersecretariat in connection with the claims related to State Encouragements to Investments and expenses such as court and execution fees and charges.

(2) The payments to be made by the Undersecretariat are carried out by the Central Bank of Turkey.

## Transfer, sale, export and rental

**ARTICLE 15-**(1) Transfer, sale, export and rental of the machinery and equipment within the scope of the investment certificate whose investment completion visa is done is free after the elapse of five years following the purchase. However, the sale of machinery and equipment should not prevent the production process of the undertaking at least for five years.

(2) In case of sale of the machinery and equipment upon expiry of five years as of the date of purchase within the scope of incentive certificate of which completion visa has not been done despite investment goods were purchased, the Undersecretariat may finalize completion procedures without imposing any sanctions, provided that the undertaking has been in operation at least five years.

(3) Without taking into consideration whether the completion visa has been done the Undersecretariat is authorized for giving permission to

a) transfer to any other investment with incentive certificate,

b) sale to another investor not holding incentive certificate,

- c) exportation,
- ç) rental

of machinery and equipment not more than five years elapsed since the date of purchase, entirely or partially - without disturbing the integrity of the investment.

(4) Permission of sale for machinery and equipment within the scope of incentive certificate whose completion visa has not been done or five years have not been elapsed since the date of purchase even though completion visa has been done can be granted on the condition that investment integrity is maintained. In such cases, the benefits provided through support measures are not recovered concerning the machinery and equipment for which permission of sale is granted. However, in case of cancellation of the incentive certificate for any reason, following the grant of sale permission, the benefits provided through support measures for the machinery and equipment are recovered partially or entirely according to the related legislation.

(5) In case of determination of the sale of the machinery and equipment for which five years have not been elapsed since the date of purchase without permission of the Undersecretariat, without considering whether the completion visa has been done or not, benefits if any provided through customs duties, VAT exemption and corporate or income tax reduction are recovered according to the related legislation. In case of decrease in the maximum credit amount due to decline in investment amount resulting from the sale of machinery and equipment, the overpaid amount of interest support corresponding to excess part of the credit is recovered in accordance with Article 8 and uncollected Resource Utilization Support Fund in credited imports and in investment credit transactions is recovered according to the related legislation.

(6) Rental or allowing use of machinery and equipment transitionally and without requesting any fee on the condition that products and services to be purchased by the investor having the incentive certificate is subject to the consent of the Undersecretariat.

(7) In case of commencement of execution proceedings or insolvency procedure under court decision against the investors who have completed their investments and satisfied special conditions registered on their certificate, completion visa of the certificate can be done by the Undersecretariat upon the application made by the investor, execution or insolvency authority before the finalization of sale by execution or insolvency. However, in case of finalization of sale transaction, the benefits provided to the machinery and equipment, which have not yet completed the periods prescribed for sale as of the finalization date, are recovered according to the provisions of the Law No 6183.

(8) In case of liquidation of the investor in accordance with the provisions of the relevant law, upon request of the liquidation committee or authority the provisions of the seventh paragraph can be applied.

#### **Relocation of Investments**

**ARTICLE 16-**(1) The large investments and investments within the scope of regional implementation is required to be maintained within the region concerned for a minimum period of five years as of becoming operational. However, under the consent of the Undersecretariat those investments can move to other regions if the subject of investment is included among investments deemed to be supported in the concerned region. Regarding relocations to regions having higher socio-economic development indicators or to regions where concerned investment is not supported, excess portion of the benefited amount through support measures are recovered according to the related legislation. The relocation of investments operating in the originally designated region for five years from the date of becoming operational to other regions is unrestricted. However, in such circumstances, no corporate or income tax reduction implementation is carried out for remaining part of the investment contribution amount as of the date of relocation.

(2) Investments which have been maintained for at least five years in the region concerned and investment completion visa of the incentive certificate has not been done yet are required to apply to the Undersecretariat for completion visa prior to relocation. Such investments may receive ex-post consent for re-location. Additionally, request of relocation of investments benefiting from general support measures, including the investment period, are evaluated and concluded by the Undersecretariat per project basis.

#### Investment period and completion visa

**ARTICLE 17-**(1) Investments within the scope of incentive certificates should be realized within the period foreseen as a result of the assessment performed per project basis. In case of failure in realization of the investment within the foreseen period, the investment period can be extended up to half of the original period. In case of documentation of failure in realization of the investment within the foreseen period including extensions due to suspension or cease of activities resulting from the lack of necessary documents such as permits or licenses, or proceedings of the public institutions, or in the event of force majeure or extraordinary conditions to be determined by the Communiqué, the Undersecretariat is authorized to extend additional period per project basis.

(2) Investors are required to apply to the Undersecretariat or to the authority receiving the incentive certificate application, following the expiry of the original or extension period to have the completion visa done within six months. In case of failure in application within this period, the Undersecretariat may initiate completion visa procedures *ex officio*.

(3) If deemed appropriate by the Undersecretariat, the chambers of industry and commerce, the chambers of industry, the chambers of commerce, maritime chambers of commerce, banks or the governorship at the province of the investment can be assigned to realize the investment completion procedures.

(4) In case investment cannot be completed within the foreseen period, or the minimum investment amount requirements specified in Article 4 are not satisfied, provided support

measures are recovered according to the related legislation via either cancelling the incentive certificates or imposing partial sanctions.

#### Loss of documents

**ARTICLE 18-**(1) In case of request by the investor for re-certification of the incentive certificate and its attachments due to loss of these documents, an amount of Three Hundred Turkish Liras for each document is required to be deposited in the account of accounting unit, to be retained as revenue to the budget. This amount is non-refundable.

#### Implementation

**ARTICLE 19-**(1) Implementation of the support measures foreseen in the incentive certificate by related public authorities and institutions is obligatory.

(2) Undersecretariat may delegate the implementation authority concerning certain procedures within the scope of this Decree to other public authorities and institutions within the framework of rules and principles to be determined by the communiqués.

(3) For the implementation of this Decree, the Undersecretariat is authorized to take the necessary measures considering macro-economic policies and changing conditions, to make necessary regulations, to publish communiqués concerning rules and principles related to the duties to be delegated to other public authorities and institutions, to request information from relevant institutions, to review and resolve the special cases not specified in the Decree, to carry out the necessary measures related to incentive certificates provided that force majeure and valid reasoning exists, to control the compliance with the conditions foreseen for investments and to take necessary measures according to the inspection results, to restrict procedures concerning incentive certificates of the investors who involve in falsification of documents and submit inaccurate and misleading information and documents, to cancel incentive certificates or to impose sanctions partially or entirely, for the support measures within the scope of incentive certificates.

(4) The procedure for resolution of the contradictions and disputes that may arise from implementation of the support measures within the scope of this Decree, is pursued according to the assessment of the Undersecretariat.

#### **Implementing Regulation**

**ARTICLE 20-(**1) The rules and principles regarding the implementation of this Decree and commencement of investments stated in Articles 9 and 10 of this Decree are determined by communiqués to be published by the Undersecretariat.

#### **Repealed legislation**

**ARTICLE 21-(**1) The Decree Concerning State Encouragements to Investments, which was put into force under the Council of Ministers' Decree dated 28/8/2006 and No 2006/10921, is repealed.

## **Pending Applications**

**PROVISIONAL ARTICLE 1-(1)** The applications not concluded prior to publication of this Decree shall be concluded in accordance with the provisions of the Decree in effect on the date of application. However upon request, applications concerning to issuance of incentive certificate can be evaluated in accordance with the provisions of this Decree.

## **Implementation Regarding Previous Decrees**

**PROVISIONAL ARTICLE 2-(1)** Implementation with regard to incentive certificates issued in accordance with the provisions of previous Decrees is carried out within the framework of those Decrees.

(2) In order to provide the implementation of favorable provisions of this Decree, new incentive certificates can be issued for the remaining part of on-going investments which already have incentive certificates issued within the scope of previous Decrees on condition that minimum capacity and minimum investment amount stipulated in this Decree are complied with.

(3) The second paragraph of Article 15 of this Decree also applies to the incentive certificates issued according to previous Decrees. This provision also applies to the investments issued incentive certificates that are cancelled but not imposed sanctions or sanctions imposed but not yet collected.

## **Entry into force**

ARTICLE 22-(1) This Decree shall enter into force on the day of its publication.

#### Enforcement

**ARTICLE 23-**(1) Provisions of this Decree shall be enforced by the Minister whom Undersecretariat of Treasury related.

1- Investment subjects, for which specialized industrial organized zones were established by the Ministry of Industry and Trade, benefit from encouragement measures foreseen in the region even though they are not included within the scope of selected sectors in the concerned region except for İstanbul.

2- Investments regarding cargo and/or passenger transport by maritime benefit from encouragement measures foreseen in the second region, investments regarding cargo and passenger transport by airways benefit from encouragement measures foreseen in the first region. Invesments of air taxi services are not supported.

3- Private sector investments on intercity cargo and/or passenger transport by railroad and investments on intracity cargo transport by railroad are supported in all regions. In case transport activity covers more than one region expenditures concerning railway cars are subject to encouragement measures provided for the least developed region.

4- Investments regarding heating and cooling of housings by geotermal energy or heat produced as by-product of power plants benefit from encouragement measures provided for in the region concerned.

5- Investments on subjects within the scope of European Coal and Steel Community Treaty are not supported.

6- As regards food and beverages production; completely new invesments and capacity expansion investments concerning the production of "rice, cracked wheat, ready-made food for pets, fish flour, fish oil, fish bait, bread, cake, wafer, raki (turkish spirit flavoured with anise) and beer", completely new investments and capacity expansion investments concerning the production of "dried nuts and fruits, pickle, cotton linter, tea and hazelnut", investments on "production of ready-made soups, bouillons and preparations and assortment and packaging of grains and legumes" cannot benefit from encouragement measures foreseen within the scope of regional and sectoral implementation. 7- Investments on tanning of leather are supported only in organized industrial zones.

8- In textile industry,

- unginned cotton investments are not supported.

- new, capacity expansion and extention types of investments for synthethic fibre production are not supported.

- regarding spinning and weaving ( except for wollen yarn, multifunctional nano-technological textile products, carpet, tufting, non-woven/non-knitted fabrics, sack) only modernization type of investments are supported.

#### **I – INVESTMENTS WHICH ARE NOT SUPPORTED**

#### A. AGRICULTURE AND AGRICULTURAL INDUSTRY

1. Grist products, starch and starch products and production of ready-made fodder (except rice, bulgur, ready made food for pets, fish feed and fodder production in integrated animal husbandry investments)

2. Biscuit,

3. Phyllo dough and kadayif (shredded wheat used to prepare a kind of dessert),

4. Pasta, semolina, noodle, coscous and similar products,

5. Catering companies,

6. Cube sugar,

7. Plant production (except greenhouse production, mushroom cultivation and forage crops cultivation in integrated animal husbandry investments),

8. Animal husbandry investments except integrated animal husbandry investments encouraged within the context of regional investments and conditionally encouraged animal husbandry investments.

#### **B. MANUFACTURING AND MINING INVESTMENTS**

1- Investments for the manufacturing of products enlisted in the Annex of the "Treaty between Turkish Republic and European Coal and Steel Community (ECSC) regarding the Trade of Products within the Scope of Agreement Establishing the ECSC", which is published in the Official Gazette dated 1/8/1996 and 22714.

2- Brick and roof tile manufacturing investments excluding modenization type of investments

3- Investments undertaken in mining fields under royalty agreements including those by public institutions

4- Unginned cotton investments,

5- New, extention and integration type of investments for synthethic fibre and synthetic yarn production,

6- Yarn production and weaving investments (except wool yarn, multifunctional, nano-technological textile production, carpet, tafting, unweaved and unknitted fabric, sack) excluding modernization type of investments.

#### **C. SERVICES SECTOR**

1- Education investments (excluding pre-school education, primary education, high school, graduate school, university, higher education and technical and vocational education) and investments concerning education of adults (courses, training centers etc.),

2- Health services investments excluding hospital investments, medical centers, dialysis centers, test laboratories and magnetic imaging centers,

3- Tourism accomodation facilities excluding hotels, holiday villages, apart hotels and mountain resorts,

4- Press and media investments excluding national scale daily newspaper printing services, television and radio broadcasting,

5- Studio investments for recording purposes,

6- Residential construction and contracting services investments,

7- Bus, tow truck and trailer investments for passenger and cargo transportation (Except investments undertaken by municipalities),

8- Investments aimed at wholesale and retail trade including hypermarket, trade center, shopping mall and parking lot investments,

9- Land vehicles maintenance, repair and service station investments,

10- Petroleum products (including LPG) distribution investments, gas station investments,

11- Highway resting facility investments,

12- Restaurants,

13- Yacht import investments,

14- Vehicle renting investments,

15- Laundaries and carpet washing facilities,

16- Automation investments except automation of industrial production facilities and infrastructure investments,

17- Real estate renting and business activities except software and R&D activities,

18- Investments of financial intermediary institutions except financial leasing activities,

- 19- Show center investments,
- 20- Cold storage warehouse investments with an indoor area less than 500 m2.

#### **II** - INVESTMENT SUBJECTS SUPPORTED CONDITIONALLY

#### A. AGRICULTURE AND AGRICULTURAL INDUSTRY

1- In dairy cattle livestock farming investments, at least 150 cattles dairy livestock farming and dairy products manufacturing must be integrated with fodder production unit and/or cold storage warehouse.

2- In cattle fattening investments, at least 150 cattles/period fattening and slaughterhouse must be integrated with cold storage warehouse and/or fodder production unit and/or meat production unit,

#### **B. SERVICES SECTOR**

1- Investment encouragement certificates can be issued for integrated logistic investments including an indoor area of at least 10,000 m2, where warehousing, handling- packaging, automation services are offered, including customs and insurance services provided in one or more than one place; having L2 certificate obtained from the Ministry of Transportation, which may include vehicles for domestic and/or international cargo transportation.

2- For pipe-line transportation, petroleum and natural gas products, filling and storage facility investments, investment encouragement certificicates can be issued only for expenditures for fixed plant, excluding distribution vehicles and tubes.

3- Investment encouragement certificates can be issued for the separately built fair, congress, exhibition and cultural center investments which are not in the form of shopping malls, business and/or trade centers. For fair and exhibition centers indoor area must be at least 5,000 m2 excluding parking spaces. For congress centers, required minimum seat number is 1,000.

Culture investments can be granted an investment encouragement certificate upon evaluation on project basis pursuant to the presentation of Culture Investment Certificate obtained from the Ministry of Culture and Tourism.

4- Investment encouragement certificates can be issued for sports facilities investments with a minimum fixed investment amount of 10 Million TL.

5- Investment encouragement certificates can be issued for road, maritime, air and railroad combination container transport investments which will be realized by investors certifying that they are conducting combined transport using at least two of the above mentioned means of transport, excluding container renting investments.

6- For airport ground handling services investments, vehicles used only in the apron can be included within the context of investment encouragement certificates. Passenger cars cannot be included within the scope of the project.

7- Investment encouragement certificates can be issued for airway services and/or cargo transportation investments under the condition that passenger aircrafts must have at least 100 seats and cargo aircrafts must have at least 30,000 kg cargo capacity. Except for the investments in the area of airway services and/or cargo transportation, investment encouragement certificates cannot be issued for general purposes and air taxi services.

8- Services investments aiming to supply final consumers single packages combining telecommunication, radio, television and data signals transmitted via satellite, radio, cable etc. will be evaluated on project basis and may be assigned an investment encouragement certificate. However, the investment goods used by the final consumer cannot benefit from the support measures.

9- Investment Encouragement Certificates can be issued for investments in facilities which will be realized in customs gates through built-operate or built-operate-transfer model including customs enforcement control units that will serve nationals and foreigners.

10- Infrastructure investments will be evaluated on project basis and may be assigned an investment encouragement certificate if deemed eligible.

11- Investments of public institutions, municipilaties, provincial special administrations, unions, cooperatives etc. related to their field of operation will be evaluated on project basis and may be assigned an investment encouragement certificate.
